## **Preamble**

Licensor owns certain electronic software known as BRAGI Software Package (hereinafter referred to as "Software"). Subject to all the terms and restrictions hereinafter set forth, Licensor is willing to grant a licence for the use of the Software under all of the terms and conditions of this Agreement.

### **1. Licence grant**

#### **1.1**

Subject to all the terms and restrictions hereinafter set forth, Licensor hereby grants to licensee the limited, non-exclusive, nontransferable, right to use the Software solely in accordance with the terms and conditions of this Agreement. Licensee's right to use the Software shall be strictly construed.

#### **1.2**

The use of this software is restricted to nonprofit research. No other use of the Software is permitted including duplication, distribution, creation of subsets or derivative Software from the Software. Licensee is not allowed to convey or transfer the Software or any part thereof, or allow it to be conveyed or transferred, to any third party outside the copyright boundary without the written consent of Licensor

### **1.3**

Licensee will have the right to distribute data retrieved from the Software or portions of the Software obtained by Research Results to third parties as incidental samples for illustrative or demonstration purposes only. In case of Licensee wishing to offer services other than nonprofit research or to enter a collaboration with a commercial organisation, an additional agreement will be required by Licensor, in which a fee for commercial use of the Software is to be negotiated with Licensor.

## **2. Proprietary rights**

The copyright and all other proprietary rights in the Software are the sole and exclusive property of Licensor. Licensee shall use reasonable care to prevent the disclosure, dissemination, copying and use of the Software or any portions thereof, in violation of the terms of this Agreement.

## **3. Publications**

Licensee may have the right to utilize data retrieved from the Software for the purpose of research publication. In publications describing work in which the Software was used, Licensee will cite the relevant papers of Licensor and the publication must carry the official name BRAGI and the ownership of Licensor. Licensee may not publish or otherwise disseminate research results for commercial use or sale.

## **3. Limitation of Liability**

Licensor retains copyright for the Software and the copyright boundary is the institute where the Software is installed. Licensor cannot accept any liability in connection with this software. In no event unless required by applicable law or agreed to in writing shall Licensor be liable for indirect, special, incidental or consequential damages arising out of the use of or inability to use the Software or for any loss or damage of any nature caused to any person as a result of the use of the Software (including but not limited to loss of data or a failure of the Software to operate with any other Programs), even if licensor has been advised of the possibility of such damages.

## **4. Licensor Warranty**

THE SOFTWARE IS PROVIDED TO LICENSEE "AS IS," WITHOUT WARRANTY. THERE IS NO WARRANTY FOR THE PROGRAM, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND NONINFRINGEMENT OF THIRD PARTY RIGHTS. THE ENTIRE RISK AS TO THE QUALITY AND PERFORMANCE OF THE PROGRAM IS WITH LICENSEE. SHOULD THE PROGRAM PROVE DEFECTIVE, LICENSEE ASSUMES THE COST OF ALL NECESSARY SERVICING, REPAIR OR CORRECTION.

## **5. Termination**

Licensor shall have the right to terminate this Agreement upon a breach of any of its terms by Licensee which is not cured within thirty days after written notice thereof.

Licensee's access to the Database shall cease immediately at termination of the Agreement by breach of the terms and conditions.

**6. Assignment**

This Agreement may not be assigned by Licensee without the prior written consent of Licensor.

**7. Final Provisions**

**7.1**

This Agreement may only be amended or modified in writing. Should one of the regulations of this contract be invalid, the others will stay in place. Instead of the invalid regulations, a new one will be inserted that will reflect as far as possible the commercial aim of the invalid regulation.

**7.2**

This Agreement shall be governed by and construed in accordance with the laws of Germany. Place of court is Braunschweig.
